Sub: TANGEDCO - Vigilance Cell – Allegation against Tmt.y.D.Prema (then) Assistant Engineer/O&M/Sholingallur (now) Assistant Executive Engineer, O/o.Chief Engineer/System Operation/Chennai and Thiru.R.Gopu (then) Assistant Executive Engineer/O&M/Sholingallur (now) Assistant Executive Engineer/O&M/Kelambakkam regarding certain irregularities in duties – Enquired – Action Suggested.

I am to inform you that Vigilance Cell has conducted enquiry into the petition received from Thiru.A.Sethu containing allegation against Thiru.Dharmaraj, Assistant Engineer/O&M/Sholingallur and Thiru.Paulraj, Line Inspector/Sholingallur that they have attempted to effect supply in disputed land S.F.No.507/1. It was also alleged that name transfer was illegally executed in Service Connection No.280-005-147 from Tmt.y.Kalyani.

2. On enquiry, it revealed that Service Connection No.280-005-147 was effected in the name of Tmt.y.Kalyani on 23.07.2000. Tmt.y.Kalyani was expired on 02.07.2010. The name transfer application was registered on 26.11.2014 and name transfer was executed on 01.12.2014 without proper documents. Both transferor and transferee signatures are same in the application and no legal heir certificate attached as transferor Tmt.y.Kalyani was expired. The Enclosure forms are kept incomplete. Tmt.y.D.Prema (then) Assistant Engineer/O&M/Sholingallur (now) Assistant Executive Engineer, O/o.Chief Engineer/System Operation/Chennai and Th.R.Gopu (then) Assistant Executive Engineer/O&M/Sholingallur (now) Assistant Executive Engineer/O&M/Kelambakkam were failed to notice the above mistakes and simply forwarded the application to the O/o.AAO/ITC and the transfer has been executed. Hence, the allegation levelled against Tmt.y.D.Prema (then) Assistant Engineer/O&M/Sholingallur (now) Assistant Executive Engineer, O/o.Chief Engineer/System Operation/Chennai and Thiru.R.Gopu, (then) Assistant Executive Engineer/O&M/Sholingallur (now) Assistant Executive Engineer/O&M/ Kelambakkam were held as Substantiated.

3. I am therefore direct you to take action on the following and send the action taken report to Vigilance Cell early:-

- i. to initiate "Major Disciplinary Proceedings" against Tmty.D.Prema (then) Assistant Engineer/O&M/Sholingallur (now) Assistant Executive Engineer, O/o.Chief Engineer/System Operation/Chennai and Thiru.R.Gopu, (then) Assistant Executive Engineer/O&M/Sholingallur (now) Assistant Executive Engineer/O&M/Kelambakkam for their proved lapses.
- ii. the name transfer executed in the name of Tmty.Kalyani (Service Connection No.280-005-147) without proper documents should be cancelled.

4. Ensure that the Disciplinary Proceedings initiated against the above said officers, it should be finalized within stipulated time as per B.P.Ms (Ch) No.142 (SB), dt.13.04.87 reiterated in Board's Memo No.68860/A23/A232/99-1, Dt: 01.02.2000.

5. I am also direct you to ensure the following:-

- (i) Copies of the final order issued have to be furnished to Vigilance Cell within three months.
- (ii) Entries have to be made in the Service Book of the respective official, if any punishment awarded to them.
- (iii) Copies of the extract of the Service Book should be furnished to Vigilance Cell.
